# 23/016 Correspondence and Clerk's Report

**Elections 2023** Breckland DC had confirmed that photo id would be required to be able to vote in the May 2023 elections. Details of the election timetable and nomination paperwork are on the website and the notice board.

Deadline for receipt of Nominations – Tuesday 4 April – 4pm, 2023 Allotments

All allotment rents had been received. Plots 20 & 20A marked out and numbering changed to mark out 4 half plots.

Plots 20A & B remain vacant. Plots 20C and D have been rented Plot 5 is coming vacant in the next few weeks and is another half plot.

All vacant plots would be marked with wooden stakes, so they are clearly visible for any potential plot holders.

A working party had been arranged for the 25<sup>th of</sup> March to cut back and clear the overgrown areas - Councillor Paul reported that the working group had managed to clear a lot of the overhanging branches and hedges and had made good progress. A further working group would be arranged in the Autumn.

Report on development land off Whissonsett Road – Highways approval and approval to build above slab level.

It was agreed that there had been a lot of issues and concerns raised with Breckland regarding the work being undertaken on the development and issues regarding the impact on the local roads. It was agreed to invite David Winch from The Land Group to the May meeting to give an update on what was happening regarding the development.

#### 23/018 Items for Discussion

018.1 **Commemorative tree** for the Queen's Platinum Jubilee – this would be planted in April on the Campyngland. A tree guard would be placed around the tree for protection and the money from the recycling income would be used to fund this. A commemorative plaque would also be placed on the area near the tree.

018.2 **Coronation 6 May 2023** – the Gala committee were organising various events for the Coronation celebrations in the village which would include a bbq. The Parish Council would be covering the insurance costs and would require a risk assessment for the insurance company to approve. Details would be circulated in the village and on social media. 018.3 **Play area** – It was agreed that the replacement posts for the 2-bay swing set would be dug out and new posts installed. The equipment would then be reinstated after it has received a safety inspection.

The Clerk was asked to order 13 bags of postcrete for collection and Councillors Joice and Loades would organise volunteers to undertake the work. It was not possible to engage contractors to undertake the work due to the very high costs quoted.

018.4 **Notice Board refurbishment**- Councillors were still trying to find a local person to help with the refurbishment of the notice board.

018.5 **Defibrillator** – The Clerk reported that it required an annual check which she was arranging.

018.6 **Trees-** The Council were still awaiting the report following the 2 trees on Campyngland identified as decaying. This would be circulated as soon as it was received. 018.7 **Elections 2023** – this had been discussed under agenda item 23/016.

018.8 **Date of Next Meeting** – Due to the statutory regulations that the meeting must be held within 14 days of the elections it was agreed to change the date to Monday 22 May 2023
